Market Summary

The stock market on Friday Surged over 700 points and concluded the session in the green zone amid positive sentiments led by political clarity and decline in inflation. The Benchmark KSE-100 index made an intra-day high and low at 65,486.45 (908 points) and 64,530.20 (48 points) respectively while closed at 65,325.68 by gaining 747 points. PKR in today's interbank depreciated by Rs 0.08 against USD and closed at Rs 279.19. The value of shares traded during the day was Rs13.372 billion. Market capitalization stood at around Rs 9.296 trillion. Overall, trading volumes for the day decreased to 344 million shares compared with Thursday's tally of 424 million. KOSM was the volume leader with 71.4 million shares, gaining Rs0.67 to close at Rs5.36. It was followed by KEL with 19.4 million shares, losing Rs0.03 to close at Rs4.87 and TREET with 17.5 million shares, gaining Rs0.72 to close at Rs18.02.

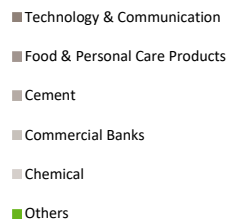

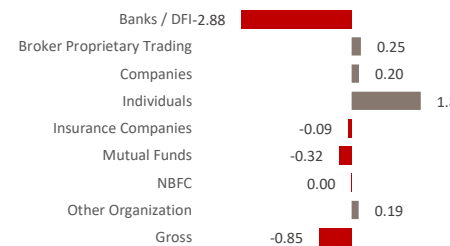

Overall Sector Turnover (%)

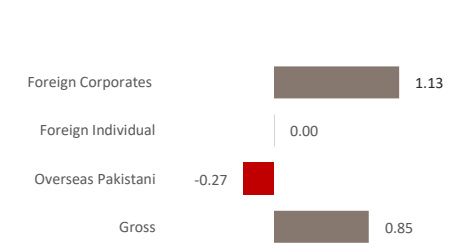

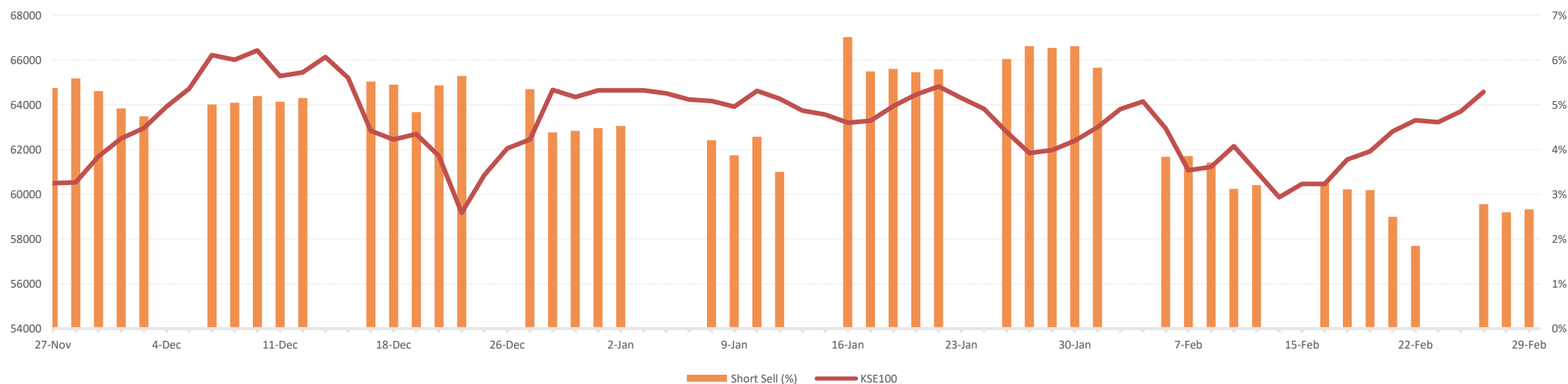
