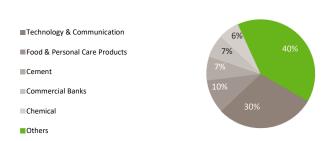

## **Market Summary**

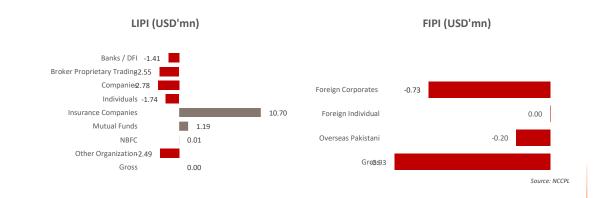
The stock market on Thursday remained bullish, achieving a new all-time high level of 67,246 after breaking the previous record of 67,094. This surge was fueled by positive sentiments surrounding macroeconomic stability and foreign investments. The Benchmark KSE-100 index made an intra-day high and low at 67,246.02 (698.24 points) and 66,690.94 (143.16 points) respectively while closed at 67,142.12 by gaining 594.34 points. PKR in today's interbank appreciated by Rs 0.0072 against USD and closed at Rs 278.0333. The value of shares traded during the day was Rs16.156 billion. Market capitalization stood at around Rs9.414 trillion. Overall, trading volumes for the day increased to 421.02 million shares compared with Wednesday's tally of 354.53 million. PTC was the volume leader with 55.7 million shares, gaining Rs1.11 to close at Rs18.42. It was followed by LOTCHEM with 27.2 million shares, gaining Rs0.03 to close at Rs19.56 and TELE with 25.5 million shares, gaining Rs0.05 to close at Rs9.29
