## Market Summary

The stock market on Wednesday opened on a positive note and concluded the session in the green zone as Trump again asserted the war with Iran would end “very quickly”. The Benchmark KSE-100 index made an intra-day high and low at 165,081.69 (2,185.01 points) and 162,895.74 (-0.94 points) respectively while closed at 164,831.42 by gaining 1,934.74 points. PKR in today’s interbank appreciated by Rs 0.0114 against USD and closed at Rs 278.5602. The value of shares traded during the day was Rs 22.089 billion. Market capitalization stood at around Rs18.202 trillion. Overall, trading volumes for the day decreased to 384.51 million shares compared with Tuesday’s tally of 389.81 million. SSGC was the volume leader with 25.3 million shares, gaining Rs0.71 to close at Rs25.93. It was followed by BOP with 24.6 million shares, gaining Rs0.5 to close at Rs33.43 and WTL with 22.8 million shares, gaining Rs0.01 to close at Rs1.3.

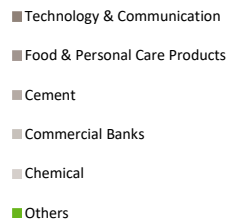

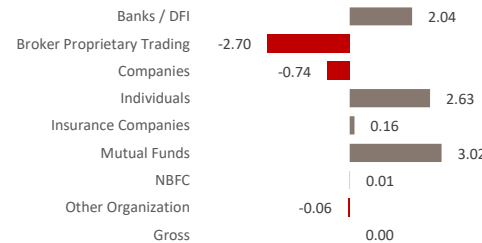

### Overall Sector Turnover (%)

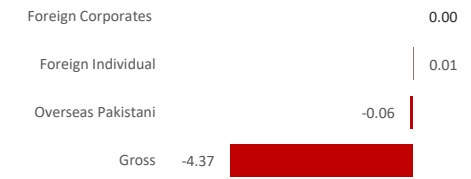

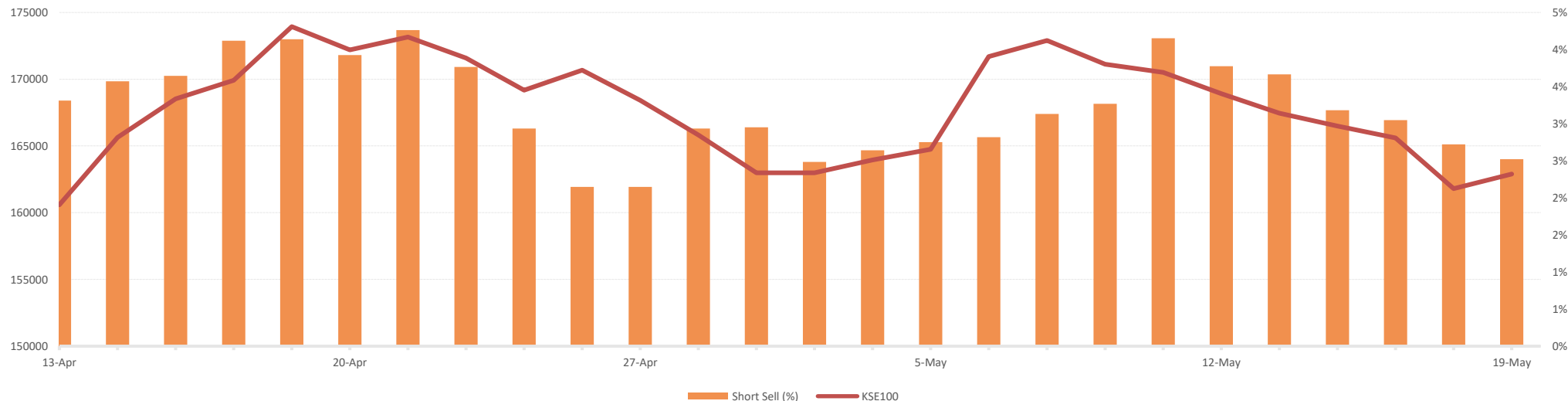
